Project Measures:

The objective of the Implementation Consultant's (IC) assignment is to provide assistance in engineering, planning, design and construction supervision to WAJ (PEA) to ensure an effective realization of the Project with the following main components / scope of measures (to be treated indicatively and to be specified in detail in the ToR):

- **Component 1:** Construction of cells 2 and 3 of the biosolids mono-landfill with all ancillary works and equipment.
- **Component 2:** Construction of gas collection system for cell 1, 2 and 3 and a treatment and usage system for all relevant cells (1 to 3) including all ancillary works and equipment.

The PEA is seeking to engage a qualified consultant to perform consulting services to support the implementation of the investments. The IC will examine at least the following Work Steps (WoS) (list is to be treated indicatively):

Work Step 1: Preparation of an Operational Model and Concept Design

Work Step 2: Preparation of Detailed Design and Tender Documents, incl. ESIA

Work Step 3: Assistance during Tendering

Work Step 4: Supervision of Construction Works and Supplies

Work Step 5: Services during Defects Liability Period and Closure of the Project

Work Step 6: Organization of Operation and Maintenance (Tendering and Contracting)

Eligibility:

Eligible qualified independent consultants will be defined as follows:

 a) Local consulting engineering firms satisfying the requirements as defined in this PQ document and classified as First Grade (1) in the field of Water and Wastewater and First Grade (1) in the field of Environment as per the Government Tender Directorate (GTD) classification system.

If the consultant does not have the classification in the field of Environment, then the consultant must nominate a consultant who is classified as First Grade (1) in the field of Environment as per the Government Tender Directorate (GTD) classification system; or

- b) International independent consulting firms satisfying the requirements as defined in this PQ document; or
- c) An association of local and international consulting firms both jointly satisfying the requirements as defined in this PQ document. The local consulting firm shall also meet the requirements mentioned under a).

This prequalification for consulting services will be guided by the latest version of the "Guidelines for the Procurement of Consulting Services, Works, Plant, Goods and Non-Consulting Services in Financial Cooperation with Partner Countries" (version of March 2021), see <u>https://www.kfw-entwicklungsbank.de/International-financing/KfW-Development-Bank/Publications-Videos/Publication-series/Guidelines-and-contracts/</u>. It is foreseen to assign the services to an independent consultant firm with proven experience in the sector and the region. Cooperation between international and national organisations is highly encouraged. The minimum annual turnover shall exceed 4,000,000 EUR.
