The bidding documents state that the Tender Security should be issued in accordance with Jordanian law, while the Form of Tender Security specifies that it shall be subject to the Uniform Rules for Demand Guarantees (URDG) 2010 Revision, ICC Publication No. 758. This presents a contradiction. Kindly clarify which of the two requirements shall be followed.	The Security shall be enforceable in Jordan.  The law governing the Security may be chosen by the Tenderer and written inserted into the standard form, at the location provided.  The Security will be subject to the stated rules (URDG-2010. ICC Publication 758). The rules are operable regardless of the governing law so there is no contradiction.	7. 12. 2025.
