Project measures:

The Water Authority of Jordan (WAJ) has received financing from German Financial Cooperation through KfW Entwicklungsbank (KfW) towards the cost of the Project "Improved Access to Water, Water Distribution Performance and related Sewerage Disposal in Irbid Governorate for Host Communities and Syrian Refugees, Package B – Sewerage Extensions", and intends to apply part of the proceeds toward payments under the contract for **Lot 1 – Sewerage Extensions Hakama**. KfW retains certain approval rights, including approval of the contractor(s) selected. However, KfW will not be a party to the Contract.

The Water Authority of Jordan (WAJ) now invites sealed Bids from eligible bidders for the construction of:

- 53.9 km gravity sewer pipeline of corrugated HDPE pipes diameter ID200, ID250 and ID400 mm,
- 6.7 km house connection pipelines of corrugated HDPE pipes diameter ID150 mm,
- 1.3 km pressure pipelines of DI pipes diameter DN 200 mm,
- 1 no. sewage pumping station,
- 1 no. rehabilitation of existing sewage pumping station,
- Supply and installation of a SCADA system,

in Hakama community and South Hakama in the east of Irbid, during a construction period of 18 months.

As global and local concern about the current COVID-19 outbreak grows, we shall do our best to ensure public health and safety. Accordingly, all Applicants are required to incorporate recognised measures to reduce the spread of coronavirus in their Health and Safety Plan, in compliance with health and safety

instruction issued by the Jordan Ministry of Labour.

Note that the Project is at ESHS level 2.

Local Jordanian contractors shall be classified as Grade (1) in Water and Wastewater as per the GTD classification. International contractors shall demonstrate at least equivalent qualifications. Contractors which demonstrate adequate experience may qualify for the above-mentioned works.

Duration of construction is 18 months with a 24-month Defects Notification Period. Bidding will be conducted by means of the International Competitive Bidding procedure with qualification as specified in the KfW Guidelines for Procurement of Goods, Works and associated Services in Financial Cooperation with Partner Countries ("KfW Guidelines"), Single Stage Procedure.

and may inspect the Bidding Documents at the address given above from 09.00 hours to 15.00 hours on working days (Sunday to Thursday).

A complete set of Bidding Documents in English may be purchased by interested eligible Bidders on the submission of a written application to the Tender Department of WAJ at the address given above and upon payment of a non-refundable fee of **1,000 JOD** (one thousand Jordanian Dinars). The method of payment will be cash.

Qualification Documents and Bids must be delivered to the address indicated in the clause ITB 22.1 of the Bidding Document on or before **[5/7/2023 at 12:00 Jordan Time]**. Electronic bidding will not be permitted. Late Qualification documents and Bids will be rejected.

Qualification Documents and Bids shall be submitted as one sealed package consisting of the following sealed envelopes:

Envelope 1: Qualification Documents (including the bid security and a CD of the Qualification Documents)

Envelope 2: Technical Proposal (including CD of the Technical Proposal)

Envelope 3: Financial Proposal (including CD of the Financial Proposal). Note that both the Letter of Bid and the priced Bill of Quantities must only be included in Envelope 3.

All three envelopes must be sealed and inserted within the main package. Every envelope within the package shall be clearly marked with the number and name of the envelope followed by the name and number of the tender assignment, and the name of the bidder. The Financial Proposal shall be endorsed: "Confidential".

In the first public session, only the Qualification Documents will be opened in the presence of the Bidders' designated representatives. In the second public session only the Technical Bids of those Bidders who have fulfilled the qualification criteria will be opened. In the third public session only the Financial Bids of those Bidders who have fulfilled the criteria for the Technical Proposal will be opened.

All **Qualification Documents** must be accompanied by a **Bid Security**. Failing to do so, leads to instant disqualification of the Bidder.

The Project is not exempted from taxes and customs duties. The Ministry of Water and Irrigation, Wa-

ter Authority of Jordan will be responsible for the reimbursement of sales taxes, customs duties for permanent material that will be used in project. As required in the Bid Documents, bidders shall show sales and withholding taxes separately in their Bids. The successful contractor shall issue invoices in which the net value and the value of the taxes and duties shall be shown separately. The contractor will not be exempted from the revenue stamp fee and has to pay it on the total contract sum upon receiving the contract award letter.
