The Jordan Valley Authority (JVA), through the Special Procurement committee hereby invites Eligible qualified independent firms with proven experience in the sector and the region to submit a proposal for the consulting services for Project Implementation Support during the Implementation Phase of the Pipe Conveyor from Telal Al-Thahab to the downstream location on King Abdallah Canal, at Turnout 95. Applicants originating from all countries of the world are eligible to tender individually, and as part of a JV of max. (2) as follows:
 - (a) Local consulting engineering firms satisfying the requirements as defined in the RFP document and classified as First Grade (1) in the field of Water and Wastewater as per the Government Tender Directorate (GTD) classification system; or
 - (b) International independent consulting firms satisfying the requirements as defined in the RFP document; or
 - (c) An association of two local consulting firms, or between local and international consulting firms, or an international firm with a local consultant, all jointly satisfying the requirements as defined in the RFP document. The local consulting firm, regardless of whether association member or consultant, shall also meet the requirements mentioned under a) above.

Sub-Consultants, whose qualifications are offered for consideration during the evaluation of applications, may participate only in one such application. Violation of this rule will result in rejection of the applications concerned.

All services under this contract as per the scope of works and the tender documents will be awarded to one qualified consultant.

2. **Project Description:**

The primary objective of the assignment is for the Consultant to assist the Client in administering the work contract and service contract for administration and construction supervision (hereinafter referred to as "the Contracts") with due diligence.

The Consultant shall undertake the specific activities required for the execution of the tasks below. It is noted that where the Consultant is required to support the Client in the performance of its obligations as Promoter, Employer or Client, ultimate responsibility for performance of those obligations remains with the Client.


The duties and responsibilities of the Consultant, during the various periods of performance of the Services include, but are not limited to, the following:

5. The Consultant shall submit the Proposal as follows:

(a) Technical Proposal: one (1) original and 2 (two) copies;

In addition to the hard copies, the Consultant shall submit in Envelope n.1 a scanned electronic copy of the original Technical Proposal, on CD/DVD or USB flash drive in Portable Document Format (pdf) that is identical to the original Technical Proposal.

(b) Financial Proposal: one (1) original and 2 (two) copies;

In addition to the hard copies, the Consultant shall submit in Envelope n.2 a scanned electronic copy of the original Financial Proposal, on CD/DVD or USB flash drive in Portable Document Format (pdf) that is identical to the original Financial Proposal.

The Consultant shall enter the following identification on the outer and inner tender envelopes:

- The name and full address of the Consultant;
- The address for submission of Proposal given in paragraph 18.10 of the RFP;
- The name and identification number of the tender process (the words: “Consulting Services for Project Implementation Support during the Implementation Phase of Jordan Valley Water Efficiency Project: Pipe Conveyor from Telal Al-Thahab to the downstream location on King Abdallah Canal, at Turnout 95 , Tender Identification No. SKAC/2/2025”);

Tender Security:

The Consultant shall furnish as part of its Proposal a Tender Security, in original form and, in the amount of Thirty Thousand Euro (EUR 30,000) within an envelope.

Submission of applications by email is not allowed and will lead to disqualification.

Bidders are obliged to follow up the issuance of any addendum to the bid documents or answers to inquiries through the official JVA website mentioned above.

8. Late submissions received after the submission deadline will be rejected.
9. The Employer reserves the right to annul the RFP process and reject all Applications at any time, without thereby incurring any liability to the Applicants.
